25069. **APOLOGIES FOR ABSENCE**

25070. **EXCLUSION OF THE PRESS AND PUBLIC**

25071. **DECLARATIONS OF INTEREST**

25072. **PARISHIONERS QUESTIONS AND PETITIONS**
There were no items of business.
25073. **CHAIRS REPORT**
The Chair reported his attendance at the recent Bradfield Festival of Music the Abbeydale Choir performance, noting that he thoroughly enjoyed the event. He also remarked that the Bradfield Dungworth Sports Day appeared to have been a great success.
25074. **CLERKS REPORT/CORRESPONDENCE**
a) The Clerk noted an email received from a resident regarding a gully within Sensical Park.
25075. **CHRISTMAS LIGHTS TENDERS**
The Chair received and opened sealed tenders for the Christmas Lights and opened them. Councillors considered and accepted City Illuminations to carry out the Christmas Lights 2025/27 works.
Proposed by Cllr. Barrow, seconded by Cllr. Paszek and
RESOLVED: - That the Parish Council: -
a) Accept the quote from City Illuminations in the sum of £14850 plus VAT to carry out the supply and install and removal of the Christmas trees, hire, install and dismantle the 24v lighting, install and dismantle the Parish's festoon lighting, carry out pre-installation checks and switch on/off at the specified dates, for a three year period 2025 to 2027.
b) To transfer funds of £10,000 from reserves to the Christmas Trees budget giving a total budget of £374,425.
25076. **SEWAGE TREATMENT PLANT LOW BRADFIELD POST OFFICE**
Councillors received an update regarding the new sewage treatment plant and considered quotations for works involved.
Proposed by Cllr. Westwood-Gray, seconded by Cllr. Baker and
RESOLVED: - That the Parish Council: -
a) Accept the quotation from SA Hewitt in the sum of £28,100 inc VAT for the supply and installation of a new sewage treatment plant and associated works.
b) Accept the quotation from Northern Power Grid in the sum of £2294.32 plus VAT for the provision of an electricity connection to serve the new sewage treatment plant.
c) Accept the quotation from Denton Nickles for supply and installation of electric meter kiosk in the sum of £1290 plus VAT.
d) Councillors agreed to engage with the affected residents to discuss and establish a payment plan for the repayment of their share of the costs associated with the new sewage treatment plant and related infrastructure works.
